On commencement of membership of the Grenville Co-operative Credit Union, the potential member is required to make a minimum deposit of ninety dollars (\$90.00), purchase of forty (40) shares at five dollars (\$5.00) per share totaling two hundred dollars (\$200.00) and pay a registration fee of ten dollars (\$10.00) adding up to grand total of Three hundred dollars (\$300.00). No shares shall be withdrawable during the first twelve (12) months of membership, nor as long as there is any sum owing to the society in respect of money borrowed from the society, or any deposit payment of which has been demanded, except with the permission of the Board of Directors. Interest rates are subject to change at the discretion of the Credit Union or at the discretion of the Registrar of Co-operatives and as such change will be communicated with to the members in a timely manner. **With regards to Joint Accounts, only two (2) persons may comprise a Joint Account.** And any deposit or fees will be owned or borne by both members.
